# **Scope and Purpose**

he American Board of Trial Advocates, an organization with more than 7,300 of the best trial lawyers in America, is dedicated to the preservation of the right to trial by jury guaranteed by the 7th Amendment.

Educating lawyers in the art of trial advocacy is a primary goal of the Foundation of the American Board of Trial Advocates. ### Case

This case involves a claim of wrongful death which focuses on the lack of a rollover protection system (ROPS) on a model of lawnmower which was recalled and should have been retrofitted with a ROPS system. The lawn mower in question was purchased used and the original owner had chosen not to retrofit the machine when the recall was issued. On the day of the incident the new owner was loading the mower onto a heavy equipment trailer when the mower tipped over backwards, trapping him underneath the mower, where he died of compressional asphyxia. The Plaintiff is seeking actual damages, pain and suffering, funeral expenses, loss of consortium, wounded feelings, emotional distress and punitive damages. The defendant claims that there was negligence. This case includes four witnesses, two expert reports, and thirty-two exhibits.
